.LOTTO Acceptable Use Policy:

Registrants of names in the .LOTTO Registry are responsible to ensure that such Registered Names are at all times used in compliance with all applicable national, federal, regional, state and local laws, ordinances and regulations ("Applicable Laws"), including, without limitation, (i) Applicable Laws and Regulations related to lottery games and (ii) requirements imposed on members of the lottery and gaming industry by the Approved Standards Bodies representing the Lottery industry (as defined in section 3.2. of the Registration Policy, i.e. WLA, NASPL, EL, ALA, CIBELAE and APLA,) and other international lottery associations representing at least 5 State Lotteries and/or Lotteries licensed by the State to operate lottery games in the concerned jurisdiction and each of them located and operating in different jurisdictions or States. Use of the .LOTTO registry for any unlicensed and /or unregulated games of chance is strictly prohibited.

In addition to any other rights of the Registry existing under the RRA between Registry and any applicable registrar or otherwise, the Registry reserves the right to deny or cancel the registration, renewal, or transfer of any Registered Name, or to place any Registered Name on registry lock, hold, or similar status, with respect to any such Registered Name that Registry, upon reasonable belief formed after reasonable investigation, deems to be registered or used in a manner that constitutes a violation of the .LOTTO Acceptable Use Policy. A violation of the .LOTTO Acceptable Use Policy includes a Registrant knowingly targeting consumers in jurisdictions other than where the Registrant is licensed to conduct the regulated activities and knowingly selling any lottery activity that is not allowed under the applicable law of the jurisdiction where the consumer is located and thereby infringing such applicable law of the jurisdiction where the consumer is located.

Further, Registrants in violation of any Applicable Laws may be subject to prosecution or other enforcement of such Applicable Laws by the appropriate authorities.

The Registry will only review whether the use of the Registered Names constitutes one of the following: Spam, phishing, pharming, willful distribution of malware, fast flux hosting, botnet command and control, distribution of child pornography, or illegal access to other computers or networks.

If the review by the Registry is challenged, or if you feel that the use of the Registered Names is not in compliance with the .LOTTO Acceptable Use Policy for any other reason, any such claims shall be directed at the Registrant and will be referred to an Arbitral Tribunal as appointed in accordance with the [Rules of Arbitration of the International Chamber of Commerce]. All disputes arising out of or in connection with the .LOTTO Acceptable Use Policy shall be finally settled under said Rules without recourse to the ordinary courts of law. The Emergency Arbitrator Provisions shall not apply.

If the Arbitral Tribunal finds that the Registrant was in violation of the .LOTTO Acceptable Use Policy, Afilias reserves the right in its sole discretion to delete, place upon registry lock, hold or similar status a domain name following the resolution of a dispute.
