.ROCHER TLD Domain Name Registration Policy

This .ROCHER TLD Domain Name Registration Policy (.ROCHER TLD Registration Policy) sets out the eligibility criteria for domain names in the .ROCHER Top Level Domain.

The .ROCHER TLD Registration Policy may be updated periodically, without prior notice. The current version can be found at [*TBC*], and continued registration or use of a .ROCHER domain name after any update constitutes acceptance of the current version. The only remedy in case of any disagreement with the current terms of the .ROCHER TLD Registration Policy is to cancel your domain name registration.

The terms of the .ROCHER TLD Registration Policy as described below constitute the entire agreement concerning the eligibility criteria for registration of a .ROCHER domain name. It is to be read in conjunction with the .ROCHER TLD T&Cs; no other agreements or representations supplement or alter the terms of the .ROCHER TLD Registration Policy, except as expressly incorporated herein.

Any undefined capitalised term in the .ROCHER TLD Registration Policy shall have the meaning set out in the ICANN Registry Agreement applicable to the .ROCHER Top Level Domain, available at [TBC].

General/Definitions

Ferrero (or "we" or "us") means Ferrero Trading Lux S.A.

- **.ROCHER** means the .ROCHER Top Level Domain.
- **.ROCHER TLD Registration Policy** means the .ROCHER Domain Name Registration Policy which sets out the eligibility criteria for domain names in the .ROCHER Top Level Domain.
- **.ROCHER TLD T&Cs** the .ROCHER Domain TLD Terms and Conditions which sets out the terms and conditions governing the registration and use of domain names in the .ROCHER Top Level Domain.

ICANN means the Internet Corporation for Assigned Names and Numbers.

Registrar means an ICANN-accredited registrar authorized to provide domain name registration services in the .ROCHER TLD.

Reserved Names mean domain names which are unavailable for third-party registration at the time of their appearance on a list of Reserved Names.

Top Level Domain means the final characters after the dot in a domain name; in the case of "nic.rocher" this is ".rocher".

You or your means an individual or entity seeking to initiate registration of a .ROCHER domain name, or if allowed, the domain name registrant.

Terms used in the singular or plural are merely for convenience, and shall apply mutatis mutandis, as the context may require.

All communications and information under this .ROCHER TLD Registration Policy shall be in English.

Registration Eligibility

Eligibility to register or use a .ROCHER domain name (including controlling associated DNS records) is limited to Ferrero, and upon Ferrero's sole discretion its Affiliates, or Trademark Licensees.

Ferrero reserves the right, for any reason, to periodically verify .ROCHER domain name registration eligibility. Any determination as to such eligibility shall be made by Ferrero in its sole discretion, and is not subject to any further appeal mechanism or reconsideration process. Ferrero reserves the right, in its sole discretion, to suspend, cancel, revoke, or take other action it deems necessary with respect to a .ROCHER domain name registrant in the event it determines that their registration violates the registration eligibility criteria. Questions about a determination by Ferrero as to .ROCHER domain name registration eligibility should be directed to the Ferrero domain management team or Registrar.

To assist in ensuring compliance with the .ROCHER TLD Registration Policy, "privacy" or "proxy" registrations are not permitted in the .ROCHER Top Level Domain.

Domain Name Registration Rules

Domain name registrations in the .ROCHER Top Level Domain follow a four-step process managed by Ferrero or the Registrar: (i) Eligibility Confirmation; (ii) Naming Convention Check; (iii) Acceptable Use Review; (iv) Registration.

.ROCHER domain name registrations are available to eligible registrants for annual terms between one (1) and ten (10) years.

In the event Internationalized Domain Name (IDN) registrations are made available in the .ROCHER Top Level Domain, they will be subject to the .ROCHER IDN registration pairing rules as and when they are developed.

(i) Eligibility Confirmation

Only Ferrero, and upon Ferrero's sole discretion, Ferrero's Affiliates, or Trademark Licensees who agree to be bound by the terms of the .ROCHER TLD Registration Policy and the .ROCHER TLD T&Cs are eligible to register or use a .ROCHER domain name. .ROCHER domain names may not under any circumstances be registered or used by third parties other than Ferrero, Ferrero's Affiliates, or Ferrero's Trademark Licensees.

Prior to any .ROCHER domain name registration or renewal, and at any time during the registration life cycle, domain name registrations will be verified by Ferrero for compliance with the .ROCHER TLD Registration Policy and the .ROCHER TLD T&Cs including as to eligibility.

(ii) Naming Convention Check

.ROCHER domain names must meet the following technical conditions:

- a. must be at least 1 character and no more than 63 characters long
- b. must contain only letters (a-z), numbers (0-9) and hyphens or a combination of these
- c. must start and end with an alphanumeric character, not a hyphen
- d. must not be a Reserved Name
- e. domain names at the second level, must not contain a hyphen at the 3rd and 4th positions (tagged domains), unless corresponding to a valid Internationalized Domain Name in ASCII encoding (for example "xn--ndk061n").

(iii) Acceptable Use Review

By asking us to register or renew a .ROCHER domain name registration, you warrant and represent that your .ROCHER domain name registration does and will at all times comply with the .ROCHER TLD Registration Policy and the .ROCHER TLD T&Cs.

Registration or renewal of a .ROCHER domain name is subject to Ferrero's satisfaction that the Acceptable Use standards set out in the .ROCHER TLD T&Cs are met prior to, and at all times during a .ROCHER domain name registration.

(iv) Registration

Provided that the .ROCHER eligibility confirmation, naming convention check, and acceptable use review are satisfied, Ferrero will provide a secure instruction per its internal domain management process to the Registrar to proceed with the registration or renewal of your .ROCHER domain name.

If at any point prior to the registration expiration date you no longer wish to maintain your .ROCHER domain name registration, you may submit a written request by email to Ferrero at [TBC] and the Registrar requesting cancellation of your registration. Please note that if you cancel your .ROCHER domain name registration, Ferrero is under no obligation to make that domain name available for your future registration.

At the conclusion of the registration period for your .ROCHER domain name, unless you have instructed the Registrar (with a copy to us) otherwise prior to the expiration of your .ROCHER domain name registration, the Registrar will renew your .ROCHER domain name registration on the basis of an agreed standing renewal order.

Reserved Names

The following terms are reserved from registration by third parties:

- reserved terms prohibited by ICANN from availability for registration including as provided in the ICANN Registry Agreement applicable to the .ROCHER Top Level Domain, and in particular
 - 1. the terms "example", "www", "rdds", and "whois" at all levels, which at Ferrero's discretion shall be withheld from registration or allocated to Ferrero
 - 2. the term "nic", at all levels, as this term shall be allocated to Ferrero for use in connection with the operation of the .ROCHER Top Level Domain
- b. any term reserved by Ferrero from time to time in its sole discretion
