Sunrise

This Phase will run for 30 days and starts on 04/09/2014 at 10:00 AM CET, and will end on 04/10/2014 10:00 AM CET.

Holders / licensees of trademarks or holders of other prior rights or brand owners with a validated TMCH registration (and valid SMD file) can apply for this Phase.

Applied for domain name must be identical to the Eligible Trademark. Applicant may omit references to a trademark such as 'TM', 'SM' or any other references to a company type or legal form and the like from the text or word elements of the Eligible Trademark. Please see the "Sunrise Dispute Resolution Policy" for disputes in regards to Sunrise applications.

The Registrar cost for registration of a domain name in Sunrise is set to 85,00 EUR, in addition to the yearly Domain Registration Fee of 17,00 EUR.

Limited Registration Period

This Phase will run for 30 days and starts on 13/10/2014 at 10:00 AM CET, and will end on 13/11/2014 10:00 AM CET.

Citizens may prevalidate any combination of a domain name based on a variant of their personal name. All words may be swapped in place and may be separated by a hyphen. Citizens' address must be located in the Ghent area with a zipcode starting with '9'.

Businesses and non-profit organisations may prevalidate a domain name using their registered business number or VAT number. Applied for domain name must be identical to the business' name. Applicant may omit references to a trademark such as 'TM', 'SM' or any other references to a company type or legal form and the like from the text or word elements of the business' name. Multiple words may be separated by a hyphen. Business' address of headquarters or local branch must be located in the Ghent area with a zipcode starting with '9'.

Applicants must prevalidate their request at least 5 days before the end of this Phase using the .GENT Clearinghouse. Upon successful validation, they will receive a token which they can use to try and register the domain name through an official .GENT Registrar.

The cost for a validation in DGVS in this Phase is determined as followed:

Upon successful registration with a valid token in this Phase, the Registrar is also charged the normal yearly Domain Registration Fee of 17,00 EUR.

Landrush

This Phase will start on 17/11/2014 at 10:00 AM CET and will end on 19/11/2014 10:00 AM CET.

Registrants will be able to register a domain name in Landrush at a premium price through any official .GENT Registrar. Domain names will be allocated on a 'first come first served' basis. There are no restrictions as to whom may or may not register a .GENT domain name in this Phase.

The Registrar cost for registration of a domain name in Landrush is set to 85,00 EUR, in addition to the yearly Domain Registration Fee of 17,00 EUR.

General Availability

The General Availability for .GENT will start on 24/11/2014 at 10:00 AM CET.

Domain names can be registered through any official Registrar and will be allocated on a 'first come first served' basis. There are no restrictions as to whom may or may not register a .GENT domain name in this Phase.

Upon registration in General Availability the Registrar is charged the normal yearly Domain Registration Fee of 17,00 EUR.
