

.餐厅 Priority Registration Policy

General

This .餐厅 Priority Registration Policy is incorporated by reference into the registration agreements between registrars and registrants.

Priority Registration Period

Dot Trademark TLD Holding Company Limited (the "Registry Operator") will offer a Priority Registration Period for thirty (30) calendar days, followed by a quiet period prior to the start of General Registration:

- ◆ 17 April 2018 00:00 (UTC+8) – 17 May 2018 23:59 (UTC+8) is the priority registration period.
- ◆ 18 May 2018 00:00 (UTC+8) – 28 May 2018 23:59 (UTC+8) is the quiet period.

Priority Registration Rules

- Registrants shall submit the priority registration application through our accredited registrars which will be posted and updated at <http://dotcanting.com/site/cooperation>;
- The application for priority registration will not take effect on a real-time basis, .餐厅 Registry Operator will allocate the names during the quiet period;
- Allocation Rules:
 - ✧ Eligible applications which do not have an identical match (i.e. where two applications for identical domain names have been made) will proceed to allocation
 - ✧ In the case of applications which have an identical match, an application made by a holder of a registered trademark will be given priority. If two applicants are applying for an identical domain name, the applicant holding a valid trademark will be given priority over the applicant without a valid trademark. Sunrise-Eligible Rights Holders who submit an application during the Priority Registration Period will be given the same priority as registered trademark holders. In the event that a Sunrise-Eligible Rights Holder and a registered trademark holder apply for an identical domain name, the domain name will proceed to auction between them in accordance with the priority definitions as “applications which have an identical match and which have the same priority”
 - ✧ In the case of applications which have an identical match and which have the same priority, an auction will be held among the respective applicants. The Registry will enlist the services of a

professional online auction service provider to organize and conduct the auction. Registration will be allocated to the highest eligible bidder within the specified auction period. The auction fees, are payable separately, and are in addition to the domain name registration fees.

Pricing

- The price for .餐厅 Priority Registration is 3,650 CNY/year, which should be paid to the applicable registrar with the application;
- Priority Registration should be no less than 2 years and no more than 10 years;
- If the applicant submits the Priority Registration application successfully and chooses to revoke the application, the registration fee is not refundable;
- After all priority registrations are allocated, for applicant who hasn't got an allocation, registration fee will be refunded; for applicant who has got an allocation, registration fee is not refundable.

Representations and Warranties

- By making a Priority Registration application, the applicant agrees to be bound by this Priority Registration Policy, all other Registry Policies and ICANN requirements set out in the Registry Agreement, including all ICANN Consensus Policies and Temporary Policies <https://www.icann.org/resources/pages/consensus-policies-2012-02-25-en>.
